As per office report lease site of Sy. No. 70 is adjacent to the main road & Civil area which can be used for municipal purpose.

19 The Board discussed the matter at length. The CEO apprised the Board that as per Western Command letter referred at agenda side, the Board have to indicate whether the said land of the lease site is required for any municipal purpose or not.

After discussion the Board resolved that Headquarters, Western Command be intimated that Sy. No. 70 is required for municipal purpose.

20 ENGAGEMENT OF JUNIOR ENGINEER SH. AANAN SHARMA ON CONTRACT BASIS:-

Reference CBR No. 10 dated 26.04.2014

To consider the application dated 10.07.2014 received from Sh. Aanan Sharma (S/o Sh. Mohinder Sharma R/o Ishwar Blessings Madhuban Colony, Solan), JE (Civil), engaged on contract basis by the Cantt. Board Jutogh for extension of his engagement period for suitable time.

In this connection it is for the appraisal of the Board that Sh. Aanan Sharma JE(Civil) was engaged first time in 2013 and he joined his duty in this office on contract basis on 09.10.2013 for the period of 03 months on honorarium basis of Rs 14500/- per month. His above period of 03 months expired on 09.01.2014. He further requested the CEO to extend his contract for suitable time. His application was referred to the Board and Board vide its CBR No. 65 dated 09.01.2014 extended his contract for another 03 months w.e.f 10.01.2014 to 09.04.2014 by executing fresh agreement. His said period expired on 09.04.2014 and he again vide his application dated 04.04.2014 requested the CEO to extend his contract for suitable period. Again his application was placed before the Board on its meeting held on 26.04.2014 and Board vide its CBR No 10 dated 26.04.2014 extended his contract period for 03 months w.e.f 28.04.2014 to 27.07.2014 on same terms and condition on monthly honorarium of Rs 14500/-. Now his period of contract is going to be over on 27.07.2014 and he again requested the CEO vide his application dated 10.07.2014 to extend the contract for suitable period.

It is pertinent to mention here that some of the maintenance works are under progress for which technical supervision of J.E is required for proper execution of the said works. J.E also has to deal with land cases such as, encroachment, unauthorized construction, mutation, renewal of leases etc and presence of JE is required. In the circumstances explained above, the Board may consider further action in the matter.

The Board considered and discussed the matter in detail. The Board resolved that fresh advertisement be given in the newspaper for engaging J.E on contract basis by 08.08.2014. Also, after discussion and keeping in view the development works which are in progress and require J.E presence for technical supervision, the Board resolved that in the mean time the contract of Sh. Aanan Sharma S/o Sh. Mohinder Sharma as Junior Engineer (Civil) purely on contract basis on monthly honorarium of Rs.14500/- be extended for further period of <u>01</u> month w.e.f <u>11.08.2014</u> to <u>10.09.2014</u> under the provision of Section 126 of Cantt. Act, 2006 by which time the process of engagement of JE through fresh advertisement be completed.

The Board further resolved that fresh agreement be executed with Sh. Aanan Sharma S/o Sh. Mohinder Sharma for the period of contract and CEO is authorized to incur the expenditure in this regard.
